Summer is flying by and there's no shortage of union related news to be aware of. Here's a few to consider.

In June, the UAW International Executive Board, announced that it has increased its weekly strike pay for members from \$275 per week to \$400 per week. Eligibility for weekly benefits will still begin on the 8th day of a strike. In addition, the UAW eliminated a provision that a member may not receive UAW strike benefits if the member received unemployment benefits.

That could be important for Local 592 members as Illinois amended the Unemployment Insurance Act, section 604, in March of 2005 to provide unemployment benefits to workers who are locked out by their employer. As a reminder, in 2003 before this law was in place, Local 592 was locked out for 6 weeks.

According to attorney John DiJohn of Lettler Mendelson in Chicago, "under the Illinois Unemployment Insurance Act, an employer is re-

quired to contribute a specified percentage of its employees' salary into an Unemployment Insurance Fund for the payment of benefits. The amount that an employer must pay is determined by the employer's experience rating. The employer's experience rating is determined on the basis of the number of its employees that apply for and receive benefits. The new law is significant because it may increase the pool of employees that may be eligible to receive benefits under the Act. If locked-out employees are eligible for and receive benefits, the employer's experience rating may increase, resulting in additional costs to the employer". Another good reason not to lock workers out.

In the Spring newsletter, we talked about the organizing drive at Starbucks. Then, 13 locations had voted and been certified by the National Labor Relations Board to be union. As of late July, Starbucks Workers United claims 180 stores and over 1,600 workers as members. Now, not one of those locations has gotten a first contract yet.

Starbucks has closed several stores at locations which have unionized, which has trigged unfair labor practice charges from the union to the NLRB. In Rockford, the Starbucks at 3001 N. Perryville Rd voted 16-2 for union representation with Chicago and Midwest Regional Joint Board, Workers United/SEIU. If you stop by, wear your union shirt and offer encouragement.

The 38th UAW Constitutional Convention in Detroit was held July 25 -28th with Mike Fishe and Criag Fryda as our delegates. You'll be hearing more about changes, proposals and elections for International Officers when they get back. For the first time ever, individual members will be voting on officers for the UAW International Executive Board. In mid October, active and retired members in good standing will be mailed an election ballot. More information will be available this fall, at your monthly membership meeting or with your Chief Steward.

It's come to our attention that the 3% match contribution from the company to the 401k was missed on a few members that hired after January 1, 2020. This is completely different than the 4% autocontribution that starts after the 45<sup>th</sup> day of employment. If you notice this on your check stub or are not sure, please contact someone from the Bargaining Committee for clarification.

Local 592 will be walking in this years Labor Day Parade. We purchased 1,200 flying discs last year, but the parade was canceled at the last minute. We will be handing them out to children as we walk. The line up begins at 8:30am Mon-

day, September 5 at the corner of 7th street and 5th Avenue heading towards 8th street. We welcome all current members, retirees and their families to participate and walk in this parade to show their support.

We had 35 outstanding 3<sup>rd</sup> step grievances just a few months ago. The committee has been working hard to get resolution to them before arbitration. As I'm writing this, we have been able to resolve 23 of them and are now down to 12.

Lastly, please don't forget to update your address with the Union when you move. It's very important that we keep our records correct locally, as well as with the International UAW. The Local will notify the International of any change reported to us. When you change it with the company, they do NOT notify the Union. The International will need current addresses on file to send out information and voting ballots.

I hope your summer is going well and please join us at a monthly membership meeting, the union picnic or the Labor Day parade.
