On November 8th in Illinois there is a proposed amendment to the state constitution which the UAW. AFL-CIO and all other labor unions support. Illinois Amendment 1, Right to Collective Bargaining Measure will enshrine a state constitutional right for employees to organize and bargain collectively through representatives of their choosing to negotiate "wages, hours and working conditions and to protect their economic welfare and safety at work". It also prohibits laws that interfere with, negate or diminish collective bargaining agreements.

Several other states have similar protections in their state constitution but the Illinois amendment would also prohibit a state level so called "right to work" law from ever taking place. This amendment deserves a YES vote from you as a un-

ion member, retiree or even as someone who places an emphasis on state sovereignty and the ability of local voters to effect change as opposed to federal control. The only union members that likely oppose this amendment are those that support cutting off their nose to spite their face.

Opponents of Amendment 1, uber rich people, giant corporations... the usual suspects, falsely say passage of this amendment will lead to higher property taxes. When has Local 592's collective bargaining ever led to higher property taxes for you or your neighbor? That would be never, don't fall for their tricks as Halloween nears. I encourage you to vote YES on Illinois Amendment 1 Right to Collective Bargaining Measure on the November ballot.

Another election to talk about is the UAW International Executive Board election. For the first time ever, individual members will cast votes for members of the UAW IEB, not delegates at a convention. President Jackson has more information in his report, and you can also go to <u>UAW.ORG</u> and you'll find information on the candidates, replays of debates between candidates and answers about the timelines and process.

In last issue we missed including retired sister Sonia Johnson in our "Remembrance" section for members that passed away in 2021. That was pointed out to me and I want to apologize for the oversight.

In closing, Veterans Day is Friday, November 11th and it's never to early to say thanks to those that have served our great country. Freedom isn't free and I appreciate your service and sacrifice.

President's Report

Brothers and sisters:

The 2022 UAW International Officer Elections will be conducted by secret ballot in the few weeks. The offices to be filled through the election are the offices of International President. International Secretary-Treasurer, three International Vice-Presidents and nine Regional Director positions. All UAW members in good standing as of October 31, 2022, are eligible to vote in the elections, including members who are part-time workers, reinstated members, and retired members. In order to have your vote counted, your mail-in ballot must be received by the final deadline of November 28, 2022.

On October 17, 2022, the first formal mail distribution of mailin ballots will be distributed to the electorate. November 11. 2022, is the final date that replacement ballots can be requested from the Election Vendor. Lastly, November 28, 2022 is the deadline for all return ballots to be received by the designated U.S. Post Office or Postal Facility. However, November 18, 2022, is the last day by which members should place their ballots in the mail to best ensure receipt by the November 28, 2022, deadline. Please remember to update your information with us when you change addresses. This includes both active and retired members. Recording Secretary Michael Fishe will be updating our records for the local.

We have two signed agreements to resolve outstanding termination grievances. The Union has ordered the next panel of arbitrators for the Temporary Layoff Agreement the company is refusing to honor.

With Negotiations starting in the spring of 2023, the membership should start preparing financially if you can. It's the Bargaining Committee's intent to bring the membership the best possible contract to the ratification vote. We'll be sending out surveys to find out what is the most important things the membership wants changed or improved. Please rate the survey items in order of importance and there will be space to add anything extra you would like to add.

UAW International Executive Board election ballots should be mailed no later than Nov 18th

The Membership has approved the purchasing of red t-shirts to show solidarity as we approach negotiations in 2023. Our current contract for Unit 1, Collins Aerospace, expires May 21, 2023. We hope to have them ordered early enough to make sure we receive them before negotiations start. We ask that the membership wear them on Wednesdays. The more the company sees us with the red shirts on "Red Shirt Wednesdays" the more they will see that the membership supports the Bargaining Committee.

I would like to thank Vice-President Mike Roth, his wife Tina, Recording Secretary Mike Fishe, his wife Lori, District 1 Chief Steward John Cartwright, his wife Annette, District 2 Chief Steward Tyler Jackson, District 3 Chief Steward Scott Lineman, his son, and District 4 Chief Steward Craig Fryda and Jackie for all their help in the planning, setup, working during the picnic and the cleanup afterwards.

The Annual Retirees Banquet will be held on Saturday, November 19, 2022, at the Eagles Club of Rockford, 3829 11th Street Rockford, IL 61108 for retirees and their spouse/guest. The postcard reminders have already been sent out. Please RSVP if you plan on attending. Please detach the RSVP portion and return it so we can get an accurate count for the dinner. Hope to see you at the banquet.

There were a few proposed By-Laws changes for our local. One change is the start time of the monthly membership meeting from 5:00 to 4:00pm for the day shift. The other was to align the locals per diem with the International Executive Board. Both proposed changes will be reviewed by the Local 592 By-Laws Committee and then voted on by the membership at the October meeting. If approved, changes will be submitted to the International UAW and those changes will NOT go into effect until the International approves. So, dayshift meetings will continue to be at 5pm until we communicate with you that everything has been approved.

Labor Negotiations Primer: part 1 of 3

The labor agreement between UAW Local 592 and Collins Aerospace expires at midnight May 21st, 2023. We're doing a three-part series on the steps taken leading up to contract expiration so members understand the who, what, when, where and how. Here's part 1.

In January, you'll see a survey from the bargaining committee listing topics such a wages, pension, vacation, job security, health care, etc and you'll be asked to rank each in an order of most to least important. This helps the committee understand what the membership considers their priorities. They'll also be a section for you to fill out if there are specific issues in the contract that you want addressed that aren't in the survey topics.

After compiling the survey results, but before negotiations start with the company, the bargaining committee will write an opening proposal for the company to consider. This proposal will cover economic and non-economic issues. For instance, if union leaders feel that language is vague, confusing or a loophole is being abused by the company in a certain section of the past contract, they'll propose clarifications. Local 592 is also in contact with other UAW or IAM (International Association of Machinists) unions that represent workers at Raytheon Technologies. Comparing notes about recently completed negotiations and what they're seeing at their plant sites.

Negotiations with the company will likely start sometime in March. Make sure you're wearing those red shirts every Wednesday. Article 20.1 of the labor agreement is the mechanism by which one party to the agreement can give notice to terminate the agreement on May 21st. This formally begins the process of negotiating a new agreement between Local 592 and Collins Aerospace.

Safety Committee Report: Craig Fryda, Chairman

Let's discuss Carbon Monoxide. It's easy to detect with a properly installed detector, yet so many homes don't have one. A CO detector and smoke alarm can save you and your families life. Carbon monoxide is an invisible, odorless, colorless gas created when fuels (such as gasoline, wood, coal, natural gas, propane, oil, and methane) burn incompletely. Each year carbon monoxide poisoning claims approximately 480 lives and sends another 15,200 people to hospital emergency rooms for treatment. Over 200 people die from carbon monoxide produced by fuel burning appliances in the home including furnaces, ranges, water heaters and room heaters. CO poisoning can be confused with flu symptoms, food poisoning and other illnesses with symptoms including shortness of breath, nausea, dizziness, light headedness or headaches. High levels of CO can be fatal, causing death within minutes. People can die when they improperly use gas generators, charcoal grills, and fuel-burning camping heaters and stoves inside their homes or in other enclosed or partially enclosed spaces.

How to properly install a detector:

Install a carbon monoxide (CO) alarm (also called detectors) in the hallway of your home near sleeping areas. Avoid corners where air does not circulate. Follow the manufacturer's instructions to test the CO alarm every month. Do not use a CO alarm in place of a smoke alarm. Have both.

Tips to make sure you do not generate CO in your home:

Make sure all household appliances are installed according to manufacturer's instructions and local building codes. Most appliances should be installed by professionals. Have heating systems (including chimneys and vents) inspected and serviced annually, checking for blockages, corrosion, partial and complete disconnections. Only burn charcoal outdoors, never inside a home, garage, vehicle or tent. Always make sure to turn off any gas-powered engine, even if the garage door is open. Do not use gas appliances such as ranges, ovens or clothes dryers for heating your home.

What to do if you suspect you are being exposed to CO:

Know the symptoms of carbon monoxide poisoning: headache, dizziness, weakness, nausea, vomiting, sleepiness, and confusion. If you suspect CO poisoning, get to fresh air immediately, and then call 911. Treat the alarm signal as a real emergency each time. If the alarm sounds and you are not experiencing any symptoms described above, press the reset button. If the alarm continues to sound, call the fire department.

I've responded to many CO alarm calls as the Captain of the Edgerton Fire Department, and a lot of them are from low batteries or unmaintained detectors. I will also tell you I'd rather go to 100 "false alarms" than have someone not call because they aren't sure. Call the FD if it's going off and we can use our meters to verify if there is CO in your home or not. It can be the difference between life or death.

Take care, and as always be safe at home and at work.
