In April, workers at the Volkswagen factory in Chattanooga, Tennessee voted to be represented by the UAW with 73% of the votes cast. The National Labor Relations Board has certified those results, and the UAW and Volkswagen put out a joint statement saying they look forward to working with together to build quality vehicles and will enter negotiations for a fair contract later this year. Two previous attempts to organize Volkswagen Chattanooga by the UAW had failed, but recent successful negotiations with GM, Ford and Stellantis helped convince employees that union representation would benefit them. Worker Vicky Holloway, a 13-year veteran of the plant, said she voted for the UAW because, "right now we have no say. It's like our opinions don't matter." Most successful organizing drives involve more than just salary increases. Safety, job security, and input to decision making, are huge motivators as well.

Unfortunately, in May the UAW lost a vote to organize the workers at

the Mercedes-Benz plant in Vance, Alabama. 56% of the vote was against being represented, and this was the third defeat for the UAW at this plant since it was built in 1997. Unfair labor practice charges were filed against Mercedes-Benz by the UAW and the union is asking the NLRB to vacate the results and hold a new election. Some of the charges are that the company fired pro-union workers, forced workers into captive audience anti -union meetings and interfered with workers ability to advocate for the union. The UAW said in a statement, "all these workers ever wanted was a fair shot at having a voice on the job and a say in their working conditions. Let's get a vote at Mercedes in Alabama where the company isn't allowed to fire people, isn't allowed to intimidate people, and isn't allowed to break the law and their own corporate code, and let the workers decide."

In Lordstown, Ohio, UAW Local 1112 ratified their first contract with Ulitum Cells with a 98% yes vote. The plant builds battery cells for GM electric vehicles and was non-union

when it opened in 2021. Workers made \$16.50 per hour but under the new union contract, they'll make \$35 an hour by 2027 and received a \$3,000 signing bonus when the contract was ratified. With Ultium Cells opening another large plant in Spring Hill, Tennessee soon, and more battery plants for other companies in the plans, UAW ranks could continue to grow in this emerging industry.

According to the Center for American Progress, workers are voting to join unions at the highest rate in 15 years. Helped in part by a strong jobs market, a pro-worker National Labor Relations Board under President Biden. and front-line workers tired of being ignored, under appreciated and overworked, people are rediscovering the benefits of union membership. In 2023, there were 1,777 union elections for representation. The most since 2010.

With that being said, we're not allowed to give out retiree jackets, attendance prizes at the annual picnic, or attendance prizes at the membership meetings going forward. This isn't popular, but please understand that neither our local executive board or the general membership as a whole can go against the UAW Constitution.

Local 592 will be walking in this year's Rockford Labor Day Parade. Please remember that if you ordered a T-shirt for the Labor Day Parade and indicated that you would walk in it but do not show up, you will be expected to pay for the shirt. We purchased 1,200

The Restoration Benefit arbitration that took place on April 10 is still possibly a month away from being awarded.

When you decide to retire, it is your responsibility to notify the company of your last day on the active payroll. The Union does not notify them.

For our retirees, if you're having benefits issues, you must contact the Benefits Service Center first. They can be contacted by calling 800-243-8135. Please ask for a ticket number from them so the Union can help if the issue is not resolved. If you're a surviving spouse, you can contact the Advocacy Support Center at 800-828-8100 M-F from 8am-6pm. If a retiree passes away, to receive the life insurance, call New York Life at 800-858-9203.

When Ryan Ostergard took a posting in a different department that was outside of his Chief Steward district, the office was vacated. Andy Jarvis was serving as Sergeant-at-Arms and decided to resign from that position to run for District 2 Chief Steward. Nominations were held on June 2nd. Dale Vorndran was nominated for the open position of Sergeant-at-Arms and Andy Jarvis for D2 Chief Steward. Since they were unopposed, no election was necessary, and they were sworn in to their respected offices at the monthly membership meeting on June 26th.

Safety Committee Report: Craig Fryda, Chairman

Summertime always implies lots of sunshine, family, fun and outdoor activities. Summer also provides opportunities for hazards like sunburns, dehydration, heat, and sun overexposure. To ensure your family has a safe wonderful summer, check out these summer safety tips and precautions.

Staying hydrated is the most important summer safety tip. To avoid dehydration and heat related illnesses, you need to replenish fluids lost through sweating. Water and sports drinks with electrolytes are the best. Avoid sugary, alcoholic, or caffeinated beverages as they tend to increase the release of fluids. Don't ignore the signs of dehydration which are dry sticky mouth, headaches, fatigue, and cramps. Heat related illnesses occur because of the body losing excessive amounts of water through sweating and the body's inability to cool down. Familiarize yourself with the warning signs: cramping, light sweating that gives way to more profuse sweating, feeling lightheaded, fatigued, and nauseous. This is heat exhaustion! Uncontrolled heat exhaustion can rapidly escalate into a heat stroke situation if left unchecked. Then when the body ceases sweating it's no longer cooling itself and you become dizzy, confused with hot dry skin and rapid pulse. These are indications of heat stroke!

If you or someone is experiencing signs of heat illness: move to a cool shady or air-conditioned space, replenish fluids, use fans, ice, cool towels, or other methods to bring the body's temp down. If symptoms don't subside within 15 to 20 minutes, call for medical help. Monitor breathing and be ready to give CPR if needed.

Sunburns also affect the body's ability to cool itself, and increase your risk of skin cancer. If you're going to be out in the sun, be aware the sun's rays are strongest between 10am and 4pm. Liberally apply a sunscreen with a SPF (sun protection factor) value of 30 or higher, and reapply throughout the day. Wear loose fitting clothing with long sleeves and long pants, and don't forget a hat and sunglasses.

Under NO circumstances ever leave your children or pets in an unattended parked car in hot weather, even for just a few minutes! Children and pets are more sensitive to heat than adults and it doesn't take as long as the effects are amplified in car acting like a greenhouse. If you see a person or animal trapped in a hot car, call for help immediately.

Besides not locking your dog in the car, don't forget your pets feel the effects of extreme heat too. Make sure to provide them with plenty of water, and if possible, a shady spot to keep cool. Watch for signs of heat stress like heavy panting or labored breathing. Keep them cool by hosing them down, let them lick ice cubes or moving them to a cool place.

So, when the temps soar...

Remember to pace yourself, don't overdo it and avoid strenuous activities in the heat of the day. Keep hydrated.

Wear sunscreen and loose-fitting clothing with a hat.

Know the signs of heat related illnesses and what to do.

Never leave kids or pets in car unattended in hot weather.

Pay attention to your own body's signals and check on children and pets regularly.

Be mindful of elderly, house bound, and others who may be reluctant to ask for help.
